The several persons whose names are hereto subscribed, and whose descriptions are contained below, and of whom *ten* are engaged as sailors, hereby agree to serve on board the said ship, in the several capacities expressed against their respective names, on a voyage from *London to Punta Arenas and any ports and places on the Western and Eastern Coasts of Central, South and North America, North and South Atlantic and Pacific Oceans, Australian and Cape Colonies, West Indies, and the Indian and China Seas and Straits and the Mediterranean Sea, to and fro for any period not exceeding two years, and back to the port of final discharge in the United Kingdom or Continent of Europe between the Elbe and Brest.*

Provisions issued as per the 'America' voyage, 1863-64.

When 14oz of butter are issued weekly the allowance of meat will be ½ lb less daily. No spirits allowed. Equivalent substitutes may be issued at the Master's option.

Swearing and all improper language is strictly prohibited. The vessel shall be considered fully manned with eighteen hands all told.

In witness whereof the said parties have subscribed their names on the other side or sides hereof on the days against their respective signatures mentioned.
