The several persons whose names are hereto subscribed, and whose descriptions are contained below, and of whom *eleven* are engaged as sailors, hereby agree to serve on board the said ship, in the several capacities expressed against their respective names, on a voyage from *London to Punta Arenas and any ports and places on the West Coasts of North, Central and South America the Continent of Europe including the Mediterranean Sea to and fro for any period not exceeding eighteen months and back to the final port of discharge in the United Kingdom.*

Provisions issued as per the 'America' voyage, 1863-64.

When 14oz of butter is issued the allowance of meat will be ½ lb less per man daily. No spirits allowed. Equivalent at the Master's option.

Swearing or other profane language strictly prohibited.

In witness whereof the said parties have subscribed their names on the other side or sides hereof on the days against their respective signatures mentioned.
