The several persons whose names are hereto subscribed, and whose descriptions are contained below, and of whom *twelve* are engaged as sailors, hereby agree to serve on board the said ship, in the several capacities expressed against their respective names, on a voyage from *London to Punta Arenas and any ports and places situated within the degrees of 75° North and 60° South Latitudes trading to and fro within these limits for any period not exceeding two years and back to the port of final discharge in the United Kingdom or Continent of Europe between the Elbe and Brest.*

Provisions issued as per the 'America' voyage, 1863-64.

When 2oz of butter is issued daily the allowance of meat will be ½ lb less per man. No spirits allowed. Equivalent substitutes may be issued at the Master's option.

Swearing and all other improper language is strictly prohibited. Sixteen hands all told shall be considered the ships full complement.
