Equivalent at the Master's option. No spirits allowed.

In the event of any member of the crew not being on board at the time stated in this agreement the master shall have liberty to engage another in his place at once. The ship shall be considered sufficiently manned with a complement of sixteen hands all told and all above that number extra hands.
