

AGREEMENT AND ACCOUNT OF CREW
FOREIGN GOING SHIP

(NICOYA – 19 OCTOBER 1872 – 27 AUGUST 1873)

The several persons whose names are hereto subscribed, and whose descriptions are contained below, and of whom *eleven* are engaged as sailors, hereby agree to serve on board the said ship, in the several capacities expressed against their respective names, on a voyage from *London to Punta Arenas and any ports and places on the West Coast of Central and South America, North and South Pacific Oceans and the Continent of Europe including the Mediterranean and Black Sea to and from and back to the port of final discharge of cargo in the Untied Kingdom or Continent of Europe between the Elbe and Brest. Voyage not to exceed two years.*

Provisions issued as per the ‘America’ voyage, 1863-64.

Equivalent substitutes at the Master’s option. No spirits allowed. When 14 oz of butter is issued weekly the allowance of meat shall be half a pound less per man per day.

In the event of any members of the crew not being on board at the time stated in this agreement the master shall have liberty to ship another in his place at once. Swearing on board strictly forbidden.

In witness whereof the said parties have subscribed their names on the other side or sides hereof on the days against their respective signatures mentioned.
