### AGREEMENT AND ACCOUNT OF CREW FOREIGN GOING SHIP

The several persons whose names are hereto subscribed, and whose descriptions are contained below, and of whom 10 are engaged as sailors, hereby agree to serve on board the said ship, in the several capacities expressed against their respective names, on a voyage from London to any port or ports on the West Coast of Central America Indian and China Seas and Straits, Australasian New Zealand and Cape Colonies, North and South Pacific and Atlantic Oceans, to and fro for a period not to exceed two years, and back to a final port of discharge in the United Kingdom or Continent of Europe between the Elbe and Brest.

Provisions issued as per the 'America' voyage, 1863-64. No spirits allowed. Equivalent substitutes at the Master's option. When 14 oz of butter are issued weekly the allowance of meat to be ½ lb less daily. Swearing is strictly forbidden. The ship shall be considered fully manned with sixteen hands all told.
