January 28 th 1870	Honolulu	No appearance of J Robin again engaged a man in his room, at 4s. 2d. per day. W C Jones David T Le Sauvage Mate	
January 29 th 1870	Honolulu	J Robin came on board and went to his duty. W C Jones David Le Sauvage	
January 30 th 1870 10.a.m. Sunday	Honolulu (S.I.)	Mr Priaulx was taken ill with a severe bilious attack wished to give him a little opening medicine but he refused to take any. W C Jones David T Le Sauvage	

January 31 st 1870 10 a.m. Monday	Honolulu	Mr Priaulx not feeling any better I sent for the doctor, he found him labouring under Boowoo (Sandwich Island fever) sent him some medicine and ordered him to remain quiet. W C Jones David Le Sauvage	
February 3 rd 1870 10 a.m. Thursday	Honolulu	Finding Mr Priaulx appeared worse, requested the doctor to see him again, he then sounded him and found he had caught cold, the right lung inflamed and a bad cough, changed his medicine and ordered a mustard plaster on his chest which was done. W C Jones D Le Sauvage Mate	
February 13 th 1870 11 ½ p.m. Sunday	Honolulu	Found Mr Priaulx greatly altered for the worse, sent the carpenter immediately for the first medical man that could be got. Doctor Kennedy was on board by midnight but ere he arrived life was gone, he had walked to and from the closet five minutes before he died. From the 31 st ultimo to the morning of the 13 th inst. Doctor McKeppin had paid a visit every day. W C Jones David T Le Sauvage.	
February 14 th 1870 4 p.m. Monday	Honolulu	Buried Mr Priaulx in the Nauana Valley Cemetery. W C Jones David T Le Sauvage	
February 14 th 1870 6 a.m. Monday	Honolulu	J Robin still on shore without leave. W C Jones David T Le Sauvage Mate	
February 15 th 1870 11 a.m. Tuesday	Honolulu	Got an order from H M Consul for a warrant to apprehend J Robin, he not having made his appearance. W C Jones David T Le Sauvage
